MY GROCERIES TO GO IS CRITICAL TO ENSURING THAT APPROXIMATELY 2,400 FOOD-INSECURE SENIORS RECEIVE MONTHLY FOOD ASSISTANCE. THROUGH THE MY GROCERIES TO GO PROGRAM, MFB PARTNERS WITH SENIOR CENTERS AND OTHER COMMUNITY ORGANIZATIONS ACROSS BALTIMORE CITY TO TARGET POPULATIONS OF LOW-INCOME SENIORS WHO MAY BE ELIGIBLE TO RECEIVE ASSISTANCE.

BENEFITS (SNAP, FORMERLY KNOWN AS FOOD STAMPS). SNAP OUTREACH IS OFTEN PAIRED WITH PANTRY ON THE GO EVENTS, TO PROVIDE IMMEDIATE RELIEF, AND A PLAN FOR FUTURE FOOD SECURITY.

THE DSS EMERGENCY FOOD DISTRIBUTION PROGRAM IS PARTNERSHIP BETWEEN THE MARYLAND FOOD BANK AND THE BALTIMORE CITY DEPARTMENT OF SOCIAL SERVICES TO PROVIDE EMERGENCY ASSISTANCE TO BALTIMORE CITY RESIDENTS IN NEED. WHEN A CITY RESIDENT VISITS A DEPARTMENT OF SOCIAL SERVICES (DSS) FAMILY INVESTMENT CENTER AND REPORTS THAT THEY DO NOT HAVE FOOD, THEY ARE GIVEN AN EMERGENCY FOOD VOUCHER. THESE VOUCHERS CAN BE REDEEMED AT DESIGNATED MFB NETWORK PARTNER SITES, WHICH THEN DISTRIBUTE DSS BOXES, BUILT AT THE FOOD BANK'S BALTIMORE WAREHOUSE, CONTAINING A THREE-DAY SUPPLY OF FOOD. IN FY17, 7,320 BOXES WERE DISTRIBUTED.

THE EMERGENCY FEDERAL COMMODITY PROGRAM - ALSO KNOWN AS TEFAP - IS A FEDERAL COMMODITY PROGRAM THAT PROVIDES FOOD FROM THE USDA TO ELIGIBLE CLIENTS. LAST YEAR, MORE THAN 4.8 MILLION POUNDS OF FOOD WAS DISTRIBUTED THROUGH THIS PROGRAM.

THE MARYLAND FOOD BANK OPERATES FROM THREE FACILITIES: ONE IN BALTIMORE, ONE IN SALISBURY, AND ONE IN HAGERSTOWN. IN FY 17, THE MARYLAND FOOD BANK DISTRIBUTED MORE THAN 37 MILLION MEALS TO CHILDREN, SENIORS AND FAMILIES IN NEED.
