IN FY18, 10,225 BOXES WERE DISTRIBUTED.

THE EMERGENCY FEDERAL COMMODITY PROGRAM - ALSO KNOWN AS TEFAP - IS A FEDERAL COMMODITY PROGRAM THAT PROVIDES FOOD FROM THE USDA TO ELIGIBLE CLIENTS. LAST YEAR, MORE THAN 4.5 MILLION POUNDS OF FOOD WAS DISTRIBUTED THROUGH THIS PROGRAM.

THE MARYLAND FOOD BANK OPERATES FROM THREE FACILITIES: ONE IN BALTIMORE, ONE IN SALISBURY, AND ONE IN HAGERSTOWN. IN FY 18, THE MARYLAND FOOD BANK DISTRIBUTED ENOUGH FOOD TO PROVIDE MORE THAN 37 MILLION MEALS TO CHILDREN, SENIORS AND FAMILIES IN NEED.
