THIS PROGRAM NOT ONLY PREPARES STUDENTS FOR THE WORKPLACE, BUT THEY'RE ABLE TO GIVE BACK TO COMMUNITIES FROM WHICH THEY RECEIVED FOOD ASSISTANCE THEMSELVES, BRINGING THEIR LIVES FULL CIRCLE. SINCE ITS INCEPTION IN 2010, 321 INDIVIDUALS HAVE GRADUATED FROM FOODWORKS. SERVING MEALS TO CHILDREN THROUGH EXISTING AFTER-SCHOOL PARTNERS ENSURES THEY HAVE CONSISTENT ACCESS TO HEALTHY FOOD IN A SAFE, FAMILIAR SETTING, FREE OF STIGMA. IN FY19, APPROXIMATELY 249,042 MEALS WERE CONSUMED AT 49 SUPPER CLUB SITES.

OVER THE SUMMER, MEAL GAPS FOR CHILDREN BECOME LONGER AND HUNGER IS MORE PROMINENT. THE SUMMER CLUB PROGRAM PROVIDES BREAKFAST AND LUNCH FOR CHILDREN WHO TRADITIONALLY RELY ON THEIR SCHOOL'S FREE AND REDUCED-PRICED SCHOOL MEALS DURING THE SCHOOL YEAR. LIKE SUPPER CLUBS, HOST SITES ARE LOCATED IN LOW-INCOME COMMUNITIES AND INCLUDE EXISTING INSTITUTIONS SUCH AS SCHOOLS AND COMMUNITY-BASED ORGANIZATIONS. IN SUMMER 2019, APPROXIMATELY 127,515 MEALS WERE CONSUMED AT 53 SUMMER CLUB SITES.
